
Case 1

TITLE, ABSTRACT, KEYWORDS

Title: Too long, non-focused, does not show focus, not relevant to journal scope

Abstract: Too much write up on others' works, too brief about own work. Contribution not clear. Lack of summary of findings.

Keywords: Repeat of words in title

INTRODUCTION AND BACKGROUND

- 1. Too long.
- 2. Does not show why problem is important.
- 3. Contribution is not given.

3. LITERATURE REVIEW

LITERATURE REVIEW

Summary of previous investigations lead to understanding the state of current research, its relevance, and provides an overall understanding of the literature's contribution to scholarship

- 1. Too much grey literature.
- 2. Not up-to-date.
- 3. Looks more like an annotated bibliography.
- 4. Lack of synthesis or critical analysis.
- 5. Does not bring out problem of study.




4. THEORETICAL FRAMEWORK

- 5. METHODOLOGY
- sufficiently described
- suitability of the methodology

- 1. Lack of theory or theoretical/ analytical/conceptual framework.
- 2. Not sufficiently related to study.
- 3. Out dated.


- 1. Does not show how (4) is related or used in methodology.
- 2. Irrelevant information included, but not subsequently used in analysis.
- 3. Lack of clear definition of concepts/ variables/constructs/items for analysis.
- 4. Description is general and failed to relate to study.

7. FINDINGS

- 1. Tables and figures not sufficiently selfexplanatory.
- 2. Overflow of information in one same table.
- 3. Lack of critical analysis, but only a mere description of numbers/statistics/ computation output.
- 4. Purely commentary.
- 5. Using computer printouts as tables or figures.
 - 1. Results not compared to past studies.
- 2. Does not meet study objectives.
- 3. Does not answer research questions.
- 4. Lack of new findings/findings different from others.

9. SCIENTIFIC AND ACADEMIC SOUNDNESS

- 1. Too long or too brief.
- 2. Only summary, no implications.
- 3. Did not state limitations of findings/study.

- 1. Lack of new contribution.
- 2. Methodology/analytical framework not sufficiently strong.



10. TECHNICAL

- 1. Does not follow Instructions for
- 2. Authors/submission guidelines.

11. APA STYLE OF CITATIONS AND REFERENCE

- 1. Inconsistent information with text.
- 2. Inaccurate format of citation.
- 3. Missing details.


DUAL PUBLICATION

1. Dual publication is unethical and strictly forbidden. If the article has been published in another journal, the author/s cannot submit the same article for publication consideration elsewhere.



DUAL PUBLICATION (CONTINUE)

.... Changing or modifying the title and/or the contents under the pretext that this would be a new article that qualifies as a new submission to a journal is an unethical practice..

DUAL SUBMISSION

Authors should not submit their article to another journal while that article is still being reviewed by another journal. Journals should include this on their submission checklist.
